2. For the above purpose to establish High Schools, Colleges, Technical Institute, Medical Colleges and other organizations to promote the spirit of self employment.

MANAGEMENT:-

CHAIRMAN OF THE TRUST

SECRETARY OF THE TRUST

The Secretary of the Trust shall be appointed by the Chairman vested with the powers to carrying out of the day to day administration of the Trust & also have the powers of the Management of the affairs of the Trust for and on behalf of the Board of Trustees. The Secretary will hold the post for a period of two years & eligible for reappointment.

The Trustee may meet as often as may be necessary and record the proceedings in a Minute Book incorporating the Minutes and Resolutions in regard to the manner in which the affairs of the Trust are to be conducted particular purpose of purposes for which the Trust properties and moneys may be spent or invested from time to time.

The quorum for meeting of the Board of Trustees shall be three.

The Chairman shall always preside over the meeting of the Board. In the absence of the Chairman at any time, the Trustees present may elect one from among themselves as Chairman of that meeting.

POWER AND DUTIES OF THE BOARD OF TRUSTEES:-

The Board of Trustees have power to receive donation of money/properties both movable and immovable for and on behalf of the Trust and all such properties and money shall be at the absolute disposal of Trust.

The Trustees shall have the sole discretion and power to make necessary investment of Trust properties and moneys and income thereof in the best interest of the Trust and such investments should always be in accordance with the provision of Income Tax Act, 1961 and rules thereof as in force today and hereinafter.

The Trust may open and operate Bank Account or Accounts in any bank. Any such Account or Accounts shall

Deeds of Title regarding the Trust properties and Investment books of accounts and other records relating to the Trust and shall be responsible for the preservation of the same.

ADVISORY BODY AND COMMITTEE:-

For proper and efficient administration of the Trust and for furtherance of the objects of the Trust.

The Trustees may appoint experts and advisors and
